CHARGES THAT ARE ELIGIBLE FOR <u>EXPUNGEMENT</u> (PETITION ONLY!)	
TYPE OF CHARGE	EXPLANATION
<i>Non-conviction (withdrawn, nolle prossed, dismissed, not guilty)</i>	<ul style="list-style-type: none"> • Eligible for expungement immediately following final disposition. • Grade does not matter
<i>Diversion program (e.g. ARD, Section 17)</i>	<ul style="list-style-type: none"> • Eligible for expungement following completion of diversion program, though may be waiting period depending on the program. • Grade does not matter • Fines and costs must be paid off! • For ARD, must attach ARD Completion Letter to petition
<i>Summary Convictions</i>	<ul style="list-style-type: none"> • Eligible for expungement if there is a 5-year arrest-free period following conviction • Only for convictions with <i>summary</i> grades • Fines and costs must be paid off!
<i>Convictions for clients who are over 70 years old</i>	<ul style="list-style-type: none"> • Eligible for expungement if client is over 70 and has a 10 year arrest-free period since conviction. • Grade does not matter (even felony convictions can be expunged!) • Fines and costs must be paid off!

**If not eligible for expungement,
move on to sealing analysis**

<i>Time Since Conviction</i>	10-year period without M or F conviction
<i>General Rule</i>	M2, M3, M
<i>Excluded Convictions</i>	<ul style="list-style-type: none"> • Art. B offense • Art. D offense • Firearms • Sexual offense/tier system • Cruelty to animals • Corruption of minors <p>Any conviction which arose from the same case as: conviction of M1 or higher <i>or</i> any of the offenses above</p>
<i>Disqualifying Convictions</i>	Felony, 2+ M1s or higher, 4+ Ms, indecent exposure, sexual intercourse w/ animal, failure to comply w/ registration req'ts, weapons/implements to escape, abuse of corpse, prohibiting paramilitary training
<i>Summary Convictions</i>	Conviction must be 10+ years old
<i>Non-Convictions</i>	Automatically sealed

PETITION-BASED	
<i>Time Since Conviction</i>	10-year period without M or F conviction
<i>General Rule</i>	M1, M2, M3, M
<i>Excluded Convictions</i>	<ul style="list-style-type: none"> • M1 Art. B offense • M1 Art. D offense • M1 firearms • M1 sexual offense/tier system • M1 corruption of minors
<i>Disqualifying Convictions</i>	<p>Within last 15 years, convicted of:</p> <ul style="list-style-type: none"> • 2+ M1s or higher • Any of: indecent exposure, sexual intercourse w/ animal, failure to comply w/registration req'ts, weapons/implements for escape, abuse of corpse, prohibiting paramilitary training <p>Within last 20 years, convicted of:</p> <ul style="list-style-type: none"> • Felony involving any of: Art. B, Art. D, firearms, sexual offense/tier system <i>or</i> • 4+ M2s or higher <p>Ever convicted of:</p> <ul style="list-style-type: none"> • murder, F1, or offense punishable by more than 20-years
