DUI Legislative History

Act 2018-153 (effective 12/24/2018)

Creates F-3 grading for 3rd offense DUI (highest tier); and Any 4th and subsequent DUI offenses

Act 2017-30 (effective 7/20/2017)

Modifies language in penalties (§3804(c))

Act 2016-33 (effective 5/25/2016)

Modifies rule and timing for prior offenses (§3806)

Act 2014-189 (effective 10/27/2014 & 12/26/2014)

Modifies language in grading (§3803); and Prior offenses (§3806)

Act 2012-39 (effective 7/9/2012)

Increases grade and penalty when minor in vehicle

Act 2004-177 (effective 11/29/2004)

Defines grade & penalty 10-year look-back period

Act 2003-24 (effective 2/1/2004)

Repeals 75 Pa.C.S. §3731;

Revises DUI under 75 Pa.C.S. §3802 to include tiered penalty structure

Act 2003-24 (effective 9/30/2003)

Amends BAC to .08% under 75 Pa.C.S. §3731
